

RFU Injured Players Foundation - Subject Access Request Form

The General Data Protection Regulation (Regulation (EU) 2016/679) (GDPR) provides you with the right to access your personal data held by the Rugby Football Union, including the right to obtain confirmation that we process your personal data, receive certain information about the processing of your personal data, and obtain a copy of the personal data we process.

The RFU manages subject access requests on behalf of the Injured Players Foundation (with the help of IPF staff). This SAR form only relates to personal data that the IPF possesses about you. We require that you submit this request form electronically via email to legal@RFU.com. We expect to respond to your request within one month of receipt of a fully completed form and proof of identity.

2. Proof of Data Subject's Identity

We require proof of your identity before we can respond to your access request. To help us establish your identity, you must provide identification that clearly shows your name, date of birth, and current address.

Please enclose a photocopy or scanned image of one of the following as proof of identity:

• Either a current Driving License; or

• A Birth Certificate or Passport, accompanied by a utility bill or bank statement showing your current address and dated within the last 3 months.



We may request additional information from you to help confirm your identity and your right to access, and to provide you with the personal data we hold about you. We reserve the right to refuse to act on your request if we are unable to identify you.

We accept a photocopy or a scanned image of one of the following as proof of your identity: passport or photo identification such as a driver's license, or birth or adoption certificate. We may request additional information from you to help confirm your identity if necessary.

We accept a copy of the following as proof of your legal authority to act on the data subject's behalf: a written consent signed by the data subject, a certified copy of a Power of Attorney, or evidence of parental responsibility.

To help us process your request quickly and efficiently, please provide as much detail as possible about the personal data you are requesting access to. Please include time frames, dates, names, types of documents, file numbers, or any other information to help us locate your personal data.

We will contact you for additional information if the scope of your request is unclear or does not provide sufficient information for us to conduct a search (for example, if you request "all information about me").

We will begin processing your access request as soon as we have verified your identity and have all of the information we need to locate your personal data.

If the information you request reveals personal data about a third party, we will either seek that individual's consent before responding to your request, or we will redact third parties' personal data before responding. If



we are unable to provide you with access to your personal data because disclosure would violate the rights and freedoms of third parties, we will notify you of this decision.

Applicable law may allow or require us to refuse to provide you with access to some or all of the personal data that we hold about you, or we may have destroyed, erased, or made your personal data anonymous in accordance with our record retention obligations and practices. If we cannot provide you with access to your personal data, we will inform you of the reasons why, subject to any legal or regulatory restrictions.
